

## Ocean Society of India ANNOUNCEMENT FOR AWARDING THE OSI FELLOWSHIPS

Ocean Society of India (OSI) has introduced a Fellowship program for its Life Members who have made an outstanding contribution to ocean and allied fields of Science and Technology. The current announcement is for the selection of not more than two Fellows. Fellowship for Life Members of OSI will be conferred on the most outstanding/distinguished Indian researchers and other professionals in the areas related to oceans, working anywhere in India or abroad, in recognition of their contributions to the field of Ocean sciences and related fields with exceptional merit. A minimum residency period of 10 years as Life Member of OSI shall be mandatory for the Fellowship award.

The **criteria for selection of the Fellows** may be one or more of the following numbered as (a) to (d):

- a) Personal achievements in ocean scientific research / education / innovative development in technology, as evident from original scientific publications of high standards / patents for new products & processes / new products & innovative processes that have significantly contributed to the development of the country and in particular in ocean development.
- b) Eminence in developing new and innovative fields in ocean science & technology.
- c) Eminence in developing ocean scientific institutions / departments and managing them, including membership of International ocean-related bodies.
- d) Outstanding contributions in the growth of Ocean Society of India, such as services rendered as a member of GC, organizing committees of OSI events, its publications, etc.

*Note: (a), (b) & (c) are the main criteria and (d) gives additional advantage.* 

The selection of OSI Fellows are from among OSI Life Members nominated by Vice-Chancellors of Universities / Directors or Heads of leading Academic Institutions / Directors of R & D Institutions in Scientific, Technological and Ocean related research in India / Fellows of Reputed Indian Academies OR Members of the prevailing Governing Council of OSI.
